GENERAL REQUIREMENTS

1.0 INTRODUCTION

Environmental management is good practice, which can result in a reduction in the likelihood of potential environmental risk and liability. Compliance with environmental legislation is a minimum requirement for the company and we endeavour to meet and, where possible, exceed applicable environmental legislation.

Failure to comply with legislation may result in fines, licences or authorisations being revoked, potentially high costs for remediation under the 'polluter pays principle' and damage to the company's image. The environmental impact of the company's operations needs to be reduced to a minimum.

2.0 ENVIRONMENTAL POLICY

The environmental policy is the driver for implementing and improving our environmental performance. The policy provides the basis upon which we set our objectives and targets.

3.0 ENVIRONMENTAL PLANNING

As a responsible organisation we recognise that our activities must be controlled so as to have a minimal detrimental impact on the environment. The following details the strategy employed by the company to address and control any potential threats to the environment from the operations of the company.

- **Recycling of waste.**

We will always aim to separate and sort waste arising from our operations in order to maximise the recyclable potential of the waste. Generated waste will as far as is reasonably practicable be separated at source and recycled. Litter waste arising from our operations will be controlled and collected in order to maintain the visual amenity of our premises.

- **Noise**

Noise generated from our activities will at all times be kept to a minimum and will be kept at a level acceptable to the users of the site and immediate neighbours. Any potential source of excessive noise such as maintenance /refurbishment work will be carried out at such a time so as to create no audible disruption to the public/residents or other users of adjacent properties.

- Spillage of potential pollutants

Staff will be trained in the procedure for containing and co-ordinating clean up of any potentially polluting spillage, should one occur. Any chemical that has potentially polluting properties will be stored in a designated lockable area.

- Traffic use

We will endeavour to minimise traffic use and attempts to source materials, and supplies from as near to locations as possible in order to limit excessive traffic movement.

- Energy Consumption

We will ensure that we endeavour to minimise wastage of energy from our activities and ensure that all staff are encouraged to consider and reduce energy usage.

- Use of Contractors/sub-contractors

We will monitor the activities of all contractors and sub-contractors to ensure that their activities have a minimal detrimental impact on the environment.
